RESOLUTION NO. 2017-3-Amended

A RESOLUTION ESTABLISHING THE WATER USE RATE SCHEDULE FOR WATER USERS IN THE BROKEN WHEEL RANCH IMPROVEMENT AND SPECIAL DISTRICT

WHEREAS, the Board of Directors of the Broken Wheel Ranch Improvement Service District, hereinafter the "Board of Directors", duly assembled on the 29th day of June, 2017, said meeting called for the purpose of establishing the water user rates for the water users in the District, and;

WHEREAS, the Board of Directors have reviewed the studies performed by Sunrise Engineering, Inc., hereinafter "Engineer" and the conclusions and recommendations of the Engineer, and;

WHEREAS, one of the purposes for which the improvement service district was formed is to provide an adequate supply of potable water to the properties within the special improvement service district, and;

WHEREAS, the Board of Directors, after review of the recommendations of Sunrise Engineering, Inc., input from the Wyoming State Revolving Fund, and commentary from the members of the improvement service district, hereby finds that:

There is a need to set the water usage rates for all water users in the District;

WHEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BROKEN WHEEL RANCH IMPROVEMENT SERVICE DISTRICT that the "Water User Rate Schedule" shall be set as follows::

- a. \$12 per month base O&M rate per functional well tap;
- b. \$20 per month for 0 to 10,000 gallons usage;
- C. \$0.005 per gallon for all usage above 10,000 gallons per month.
- d. Each water user will be billed monthly;
- e. Payment will be due within 25 days of receipt of each bill;
- f. All overdue accounts will be billed at a 1.5% interest rate:
- All accounts three months overdue may be subject to having their water service g. disconnected.
- The "Water User Rate Schedule" will be re-evaluated and adjusted as needed. h.

For all current water users, said water usage bills shall be collected by the District Treasurer. The implementation date for the billing of the water usage will be August 1, 2017, at the \$12 O&M rate plus \$20 per functional tap (for a total of \$32/month), with actual water usage being measured and billed (along with the \$12 O&M rate) once the water meters are installed and functional. For all future water users, the implementation date shall commence on the first day said new well tap is functional. Water usage monies are to be used for the maintenance and operating costs of the water system, with any extra monies collected via water rates being added to the Well Contingency Fund for future maintenance/repairs.

WHEREAS, one of the purposes for which the improvement service district was formed is to provide an adequate supply of potable water to the properties within the special improvement service district, and;

WHEREAS, the Board of Directors, after review of the recommendations of Sunrise Engineering, Inc. and commentary from the members of the improvement service district, hereby finds that:

1. There is a need for the District to have authority and control over the entire existing well/water system and all parts thereof, including the well taps on each lot.

WHEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BROKEN WHEEL RANCH IMPROVEMENT SERVICE DISTRICT that:

a. As of this date, the entire existing well/water system and all parts thereof, including the taps on each lot, in Broken Wheel Ranch will come under the authority and control of the District, as approved by the Broken Wheel Ranch Property Owners Association board of directors at their June 29, 2017, 5pm meeting.

RESOLUTION NO. 2017-8

A RESOLUTION ESTABLISHING THE REQUIREMENT FOR WATER METERS, TAP COST THEREOF FOR NEW CONSTRUCTION IN BROKEN WHEEL RANCH, AND OWNERSHIP THEREOF BY BROKEN WHEEL RANCH IMPROVEMENT AND SPECIAL DISTRICT

WHEREAS, the Board of Directors of the Broken Wheel Ranch Improvement Service District, hereinafter the "Board of Directors", duly assembled on the <u>29th</u> day of <u>June</u>, 2017, said meeting called for the purpose of establishing the requirement for water meters, the tap cost thereof for all new construction in Broken Wheel Ranch, and the ownership thereof by Broken Wheel Ranch Improvement and Service District;

WHEREAS, the Board of Directors have reviewed the studies performed by Sunrise Engineering, Inc., hereinafter "Engineer" and the conclusions and recommendations of the Engineer, and;

WHEREAS, one of the purposes for which the improvement service district was formed is to provide an adequate supply of potable water to the properties within the special improvement service district, and;

WHEREAS, the Board of Directors, after review of the recommendations of Sunrise Engineering, Inc. and commentary from the members of the improvement service district, hereby finds that:

- 1. There is a need to install water meters on all existing properties;
- 2. There is a need to require the installment of water meters on all new construction;
- 3. There is a need for the District to retain ownership of said meters.

WHEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BROKEN WHEEL RANCH IMPROVEMENT SERVICE DISTRICT that "Rules for Water Meters" shall be set as follows: :

- a. All existing homes in Broken Wheel Ranch will have a water meter installed as part of the well upgrade project at no cost to individual owners;
- b. As of this date, all new construction will be charged \$2,500.00 per well tap and will have a water meter installed at the expense of the Broken Wheel Ranch Improvement and Service District;
- c. Installation of water meter on new construction will only occur after receipt of well tap fee;
- d. The District will retain ownership of water meters.

Specifications for water meters will be provided to building parties.
