RESOLUTION NO. 2017-2

A RESOLUTION ESTABLISHING THE RATE OF ASSESSMENT FOR WATER AND SPECIAL IMPROVEMENTS

WHEREAS, the Board of Directors of the Broken Wheel Ranch Improvement Service District, hereinafter the "Board of Directors", duly assembled on the <u>23rd</u> day of <u>February</u>, 2017, said meeting called for the purpose of establishing assessments for water system and special improvements, and;

WHEREAS, the Board of Directors have reviewed the studies performed by Sunrise Engineering, Inc., hereinafter "Engineer" and the conclusions and recommendations of the Engineer, and;

WHEREAS, the study submitted by Engineer was conducted during a period of time when the area within the Broken Wheel Ranch Improvement Service District, hereinafter "District", experienced a loss of supply of potable water. The study concluded that improvements are needed to the culinary water system and other assets within this system. The initial estimate provided by the Engineer placed the cost of the improvements at a total of \$915,000, \$386,437 of which will be the responsibilty of the District, with a 25% loan forgiveness netting a total loan amount of \$289,827.75, and;

WHEREAS, one of the purposes for which the District was formed is to provide an adequate supply of potable water to the properties within the special improvement service district, and;

WHEREAS, the Board of Directors, after review of the recommendations of Sunrise Engineering, Inc. and commentary from the members of the improvement service district, hereby finds that:

- There is a need to provide potable water to the properties within the District;
- Improvements to the existing culinary water system are required to provide potable water to the properties within the District;
- 3. There are 37 properties within the area of the service district;
- 4. The cost of the improvements, based on the Engineer estimates, is \$915,000 total, with \$289,827.75 being the responsibility of the District, a yearly cost of \$13,847.29;
- The yearly loan cost per lot within the District is \$374.25 (or \$31.19 per month);
- The District needs to build up a contingency fund for the water system, \$45.72 will be added to the yearly loan cost per lot. The yearly amount to be assessed per lot will be \$419.97 (or approximately \$35 per month);
- 7. Said cost per lot shall be the "Rate of Assessment";

WHEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BROKEN WHEEL RANCH IMPROVEMENT SERVICE DISTRICT that the "Rate of Assessment" shall be set as follows::

a. \$419.97 per lot per year

Said assessement shall be collected by the Lincoln County Treasurer. The implementation date for the collection of the assessment shall commence on the 1st day of January, 2018, and be collected until further action of the Board of Directors. Said assessments are to be used for the construction, maintenance, and payment of any debts against the culinary water system.

RESOLUTION NO. 2017-3

A RESOLUTION ESTABLISHING THE WATER USE RATE SCHEDULE FOR WATER USERS IN THE BROKEN WHEEL RANCH IMPROVEMENT AND SPECIAL DISTRICT

WHEREAS, the Board of Directors of the Broken Wheel Ranch Improvement Service District, hereinafter the "Board of Directors", duly assembled on the <u>23rd</u> day of <u>February</u>, 2017, said meeting called for the purpose of establishing the water user rates for the water users in the District. and:

WHEREAS, the Board of Directors have reviewed the studies performed by Sunrise Engineering, Inc., hereinafter "Engineer" and the conclusions and recommendations of the Engineer, and;

WHEREAS, one of the purposes for which the improvement service district was formed is to provide an adequate supply of potable water to the properties within the special improvement service district, and;

WHEREAS, the Board of Directors, after review of the recommendations of Sunrise Engineering, Inc. and commentary from the members of the improvement service district, hereby finds that:

 There is a need to set the water usage rates for all water users in the District;

WHEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BROKEN WHEEL RANCH IMPROVEMENT SERVICE DISTRICT that the "Water User Rate Schedule" shall be set as follows:

- a. \$20 per month base rate per well tap for 10,000 gallons of water usage;
- b \$0.002 per gallon for all usage above 10,000 gallons per month.
- c. Each water user will be billed monthly;
- d. Payment will be due within 25 days of receipt of each bill;
- e. All overdue accounts will be billed at a 1.5% interest rate;
- f. All accounts three months overdue may be subject to having their water service disconnected.

For all current water users, said water usage bills shall be collected by the District Treasurer. The implementation date for the collection of the water usage bills shall commence on (date to be determined). For all future water users, the implementation date shall commence on the first day said users' well tap is functional. Said water usage monies are to be used for the maintenance and operations costs of the culinary water system.
