MTN X has taken over applying the mag to the roads, and will continue to do our road maintenance for the foreseeable future. Two issues of concern are the culvert that runs under the road towards 'the yellow house' and the lack of a culvert at the end of the Schnoor's new

driveway. During spring thaw and any significant rain these areas tend to overflow and wash out onto the road.

Suggestion was made to cut back vegetation along the roadways before the winter, Mark suggested annual Fall cleanup be the Saturday after Labor Day.

Nothing currently happening, Mark Mosgeller is hoping to receive a building permit this fall and start construction in the spring.
